

SALES CONTRACT HEALTH AND CONGENITAL WARRANTY

This warranty covers any viral diseases which could not have previously been detected starting on the possession date and for a period of fifteen (15) days. The warranty also covers MAJOR congenital defects that could cause the natural death of the animal. The congenital defect warranty covers the animal until it reaches 24 month old. The animal must be examined and cleared with a veterinarian, at the buyer's expense, within five (5) working days of possession. Failing to do so will void the present warranty. All esthetical congenital defects are not covered by the warranty. All loss of animal like accidental death, poisoning, stolen animal or disappearance or any other similar reason is not covered by the warranty. All diseases that the animal could develop after the incubation period (following the possession date) will be at the buyer's sole responsibility and expense.

During the warranty period, the animal examined and diagnosed by a practicing veterinarian and found to be suffering from any illness or malformation, will have to be returned to the breeder within twenty-four (24) hours following the diagnosis, which will have to be confirmed or denied by the breeder's own veterinarian. Depending on the result of this second assessment, the breeder reserves the right to decide if the animal will be replaced by another puppy of equal value, or be treated by the breeder's own veterinarian. If the buyer notices that the animal listed below shows signs of sickness or other covered by this warranty, the buyer MUST IMMEDIATELY return the animal to the breeder to use his warranty. If the buyer sends the animal covered under this warranty to the care of any other person such as another breeder, friend, etc. without a WRITTEN CONSENTMENT before hand of the breeder, the buyer is responsible of ALL COSTS AND RISKS that this action could represent, and the warranty is VOID AND WITHOUT ACTION by the buyer.

NO MONETARY REIMBURSMENT WILL BE MADE. All replacement of puppies will be made by the breeder by exchanging with a puppy of same the value and the breeder reserves the delay of one (1) year for such replacement.

The warranty is limited to the value of the animal bought. The buyer takes in his care and responsibility the animal as described below. The buyer cannot claim any reimbursement by the breeder for the food, boarding, care or damages of any nature that the animal could cause and to whom ever concerned or wherever this could occur. Since the breeder gives a health warranty on the animal, the breeder will not reimburse any veterinarian care bills contracted by the buyer. The buyer will solely assume all the breeder's veterinarian bills, for any animal returned under the terms of the present warranty, if the breeder's veterinarian counter-assessment of the buyer's veterinarian diagnosis is negative. This warranty is not transferable and is limited to the original buyer who dealt with the breeder.

The buyer must **scrupulously respect** the vaccination program stated in the health book of the animal and **for the complete duration of the warranty**. If the buyer does not scrupulously respect the vaccination program, the warranty is VOID AND WITHOUT ACTION by the buyer.

The warranty will apply only if the animal is fed the proper balanced dog nutrition food. The animal will have to be fed with a superior quality dog food of recognized brand.

The breeder does not give ANY warranty as reproduction and/or show animal for the dog described in this contract, even if the animal is registered to one of the recognized kennel clubs.

For any animal left or returned to the breeder without prior **written** consent, the buyer will have to pay the boarding fee of 10.00\$ a day for the costs occurred by the breeder. In such a case, five days (5) after the dog has been in the care of the breeder, if the owner does not pick-up his dog, the breeder will have, to his sole discretion, the right to sell the animal without any reimbursement to the owner whatsoever. In such a case, the breeder could still claim the boarding fee mentioned in this paragraph.

ADDITIONAL AGREEMENTS

The puppy is sold on a non-breeding agreement. The buyer **must** spay or neuter the puppy. The registration papers will only be sent/given the buyer, when a written proof from a licensed veterinarian is submitted to the breeder that the animal has been spayed or neutered. Your puppy must me spayed or neutered between 10 to 12 months of age.

If the puppy is not spayed or neutered within the timeframe allotted, the buyer agrees to pay double the amount the puppy was paid.

If the buyer allows reproduction of the animal, in any shape or form, legal action will be taken by the breeder for breach of contract.
